## Directions to The Last Green Valley office in Danielson, CT

### From the North:

On the Mass Pike (I-90) take exit 10 toward I-395 towards CT. Follow I-395 for 27 miles to exit 92. Take a right off the exit. Follow to the bottom of hill and take a left onto Rt. 12. Follow for .2 miles, TLGV is on your right in the second floor of the First Niagara Bank building.

### From the South:

Once on I-395 north, follow to exit 91W. Off the exit, follow Rt. 6 for 1 mile, then turn right onto Rt. 12/ Main St. TLGV is .4 miles ahead on your left, in the second floor of the First Niagara Bank building.

### From the East:

From Providence, take Rt. 6 west into CT. Follow Rt. 6 to the intersection of Rt. 12 north. Take a right onto Rt. 12 north. TLGV is .4 miles ahead on your left in the second floor of the First Niagara Bank building.

### From the West:

From Hartford: Take I-384 East, which becomes Rt. 6 East. Follow Rt. 6 East for 23 miles. Take a left onto Rt. 12 North. TLGV is .2 miles ahead on your left in the second floor of the First Niagara Bank building.
