TRBP Coordinator's Report

The TRBP website is still static. The website is available, but the TRBP Coordinator is no longer able to edit the TRBP website. Microsoft ended their support of FrontPage, the software used to develop the website.

• The ECCD application for a Poquetanuck Cove Bioblitz and TRBP website update from the Community Foundation of Eastern Connecticut was not funded. New strategies are needed to fund a new website. Estimated cost of the project is \$4000 to hire a contractor to set up the new website and to cover the cost of the TRBP Coordinator's time to assist with an outline and content for the new website.

- It was suggested that Connecticut College has paid internship programs and Michelle Fitzpatrick will inquire if a student is available, interested and qualified to work on this project.
- Three Rivers Community College may also have student interns that need to complete projects.
- The group discussed sending out donation appeal letters to raise funds to collect donations from partners to support a new website.

Floating Workshop XVI – Due to unforeseen complications with the water transportation for the workshop, the TRBP coordinator needed to put in a lot of extra time to line up replacement boats. TRBP is very grateful to our partners that answer our SOFW (Save Our Floating Workshop)! The US Fish and Wildlife Service Steward B. McKinney National Wildlife Refuge, under Rick Potvin, brought their vessel all the way from Westport to support our workshop, and for a reduced fee, Project O skiffs were provided to meet our transportation needs. The weather cooperated. Other in-kind contributions to the workshop included the use of the conference room at Fort Trumbull State Park, use of the meeting space at the Custom House Maritime Museum and a tour of the Groton wastewater treatment plant. We had three workshop attendees donate extra funds and with that, the workshop ended with a very small profit. The TRBP Coordinator sent out thank you letters to all our workshop supporters and has prepared a slide show summary of the events of the day.

TRBP Facebook page update: Facebook page has 16 followers! A post about the Floating Workshop was shared via the TLGV Facebook page and many people viewed it, but only 2 new "likes" were generated. Partners were encouraged to "like" and follow the TRBP Facebook page, and to share posts to generate additional interest in the organization.

Floating Workshop XVII – suggested focus on Little River watershed, National Water Quality Incentive watershed.
