Special Presentation: Professor Jack Clausen of UCONN's Department of Natural Resources and the Environment will give a presentation on a Path to Reduce Pathogens in CT Agricultural Runoff. This project is one of three Regional Conservation Partnership Project in the Thames River watershed funded in part through the USDA Natural Resources Conservation Service. Project partners include the Eastern Connecticut Conservation District, The Last Green Valley and Clean Up Sound and Harbor (CUSH) out of Stonington. Water samples will be tested using standard methods to determine the *E. coli* concentration. Samples with high counts will be further source tracked to species of origin using a specialty lab in Florida. Knowing the source of the contamination will better focus remediation efforts going forward.
