#### **Special Presentation:**

Christian Fox of The Nature Conservancy and Emily Hall of CT DEEP gave a presentation of the draft CT Blue Plan. The Blue Plan provides digital mapping of Significant Human Use Areas and Ecologically Significant Areas in the coastal areas of Long Island Sound. The area covered under the Blue Plan extend inland up to the first bridge crossing of the waterbody. The goal of the Blue Plan is for these maps to be consulted prior to developing a permit application with the intent of avoiding conflicts in advance rather than after time and money have been invested in developing plans that are not compatible with the Blue Plan. The TRBP website update

- A page was created for Water Quality and Planning.

- A Learn tab includes information about river and coastal access points, free GIS mapping links, tide predictors, paddle guides and the clickable watershed map is completed, to with links to regional watershed pages containing additional information on those rivers.

- There are several places where the "sign up for TRBP updates" shows up.

# Floating Workshop update

- The 2019 TRBP Floating Workshop will feature the Yantic River. Save the date for June 14, 2019.
- The Bozrah Town Hall has been reserved for the beginning of the workshop. First Selectman Glenn Pianka will be hosting our group. (I met him at a TRBP Plan of Work meeting in 2018.) Maximum seating is 47 people at the Bozrah Town Hall.
- Keynote address will be by DEEP fisheries on the Trout Management Program. Yantic River has a trout management area and some reaches of the river reserved for fly fishing only.
- After the indoor presentation, Dan Mullins of ECCD will showcase a rain garden in the parking lot of the town hall prior to relocating to Bozrah Agricultural Park.
- Lunch to be set up at the park. ECCD to set up their tent. People will be encouraged to bring their own chairs.
- At Bozrah Ag Park, several different hands on stations will be set up and visited on a rotational basis.
- Project O water quality monitoring
- TLGV/Lebanon IWC Riffle bioassessment with large screen hooked up to a digital microscope
- TU Fly fishing demonstration/TU mission statement and programs.
- Other?
- Seeking volunteers to organize optional morning events in the lower Yantic River
- Hike from Norwich Harbor to Indian Leap at Yantic Falls.
- Paddle from Norwich Harbor to Indian Leap at Yantic Falls (keeps the name of the workshop honest)
- If AM activities are lined up, then I will seek a representative from NPU to provide an update on the CSO separation project, possibly where an impacted storm drain empties into the Yantic River.

• ECCD applied for a grant for TRBP Floating Workshop Scholarship funds. The final grant recipients have not be determined yet.
