

Thames River Basin Partnership July 19, 2022 Meeting Notes (Draft)

TRBP Financial Report:

We begin the quarter with \$1449.85 in the TRBP passthrough account. Expenses for the workshop included \$225 for insurance for the paddling portion of the workshop and \$121.41 for refreshments, etc. totaling \$346.41. Income from the workshop fees and donations was \$367. Final workshop impact on the budget was a gain of \$20.59 ending the quarter at \$1595.44. ECCD provided a tent for the outdoor workshop at no fee.

TRBP Coordinator's Report

TRBP Floating was held on June 10, 2022 at the Plainfield Fish Hatchery. The theme of the workshop was a Celebration of the 50th Anniversary of the CT Inland Wetlands and Watercourse Act, which preceded the passage of the Federal Clean Water Act by several months. Denise Savageau, President of the CT Association of Conservation Districts, give the keynote address, followed by a talk given by Chief Ranger Bill Reid of The Last Green Valley. Bill gave the history of the three water trails (Quinebaug, Willimantic and Shetucket Rivers) recognized as National Recreation Trails by the National Park Service, and how they came about following the 2009 Source to Sea adventures organized by TLGV. He also spoke on TLGV's eagle monitoring efforts that have helped to document an increase in American Bald Eagles in CT and an increase in the known number of breeding pairs that have made their home in eastern Connecticut. Improved water quality in our rivers made it possible for both the increased use of our rivers for water-based recreation, and for the return of Bald Eagles. Jean Pillo, switching to her TLGV Volunteer Water Quality Monitoring Coordinator hat, spoke on TLGV's water quality monitoring program and data that had been submitted to CT DEEP that has been used to document water quality in the greater Thames watershed area, followed by Eric Thomas, who gave an overview on how to use a new app to determine water quality in Connecticut, and an overview of the draft 2022 Integrated Water Quality Monitoring Report to Congress that CT

DEEP was accepting public comment on through July 6. Following our outdoor tent talks, the workshop transitioned to a tour of the Quinebaug Valley Fish Hatchery led by Bryan Decker of CT DEEP. After a light lunch, many of the workshop attendees participated in an optional paddle on the Quinebaug River. Prior to the paddle, the paddlers were read a piece on the history of the First Americans that lived in this area, the Nipmuc Tribe, and asked to think about how the land may have been stewarded then vs how it is currently managed. In total, there were 17 people involved in this year's Floating Workshop. A storymap of the day's events was generated in place of a post workshop report.
